#### THE SUMMARIES

Both the NACRO and Prison Reform Trust papers provide a brief introduction to key features of the legislation. The Prison Reform Trust guide seems better if you know in which area of the entire legislation you need to be briefed whereas the NACRO paper focuses upon the sentencing framework and puts it in a context.

### **BOOKLETS**

The Quick Reference Guide and Handbook for pre-sentence reports are designed for a probation audience and relate clearly to the Probation Service training material also prepared by NACRO. All of the booklets, apart from the Quick Reference Guide, tackle one area of the legislation dealing with the key principles to be taken into account in some detail but avoid covering every possible eventuality. They also helpfully indicate where some areas for interpretation remain.

They are all very readable and well presented.

#### **BOOKS**

Not surprisingly this collection of materials is unlikely to be suitable for the busy practitioner to read through from cover to cover. They cover in detail both the principles and ramifications of the legislation. Bryan Gibson's writing is noted for its ease of comprehension and ability to render a potentially boring subject into an exciting read. That is a very important issue because many practitioners who need to develop advance familiarity with the Act could be easily tempted to avoid reading impenetrable tomes on subjects that are nevertheless important. Bryan Gibson makes for easier reading because, in my opinion, he puts the provisions of the Act into a historical and philosophical context which tells a tale.

Blackstone's Guide to me functions better than Bryan Gibson's publications as a reference text, to which one could turn for enlightenment on a variety of specific issues that are likely to tax practitioners in the criminal justice system after October 1992.

Designed for different purposes, both the Blackstone's Guide and Bryan Gibson's books should be readily available to all practitioners.
